THE CANOE RACE

1:00 PM Rules and Regulations—must be present to participate.

Place: Upper Brice Prairie Boat Landing on County ZB (See map).

Pre-register by June 18, 2007

Race length - canoes 2/kayaks 4 miles on Lake Onalaska.

Please provide your own personal flotation device (PFD). A PFD must be in boaters possession; those under 14 and non-swimmers must wear a PFD.

Canoes and paddles are available to registered participants at **781-1662. Ask for Marc or Sue.**

Categories: Canoe or Kayak

Division: Men, Women, Mixed, Youth (12-17)

Fee: \$16/participant

(\$16 + \$16 = \$32 for canoe or 2 person kayak)

Late registration (after June 18): add \$5 per participant

(No guarantee of pig roast/T-shirt)

Race day late registration: 11:30-12:30.

Race will be conducted in timed heats.

Heats will start at 3 minute intervals in mixed groups of 5 craft beginning immediately after rules and regulations at 1:00 P.M.

THE ROAST

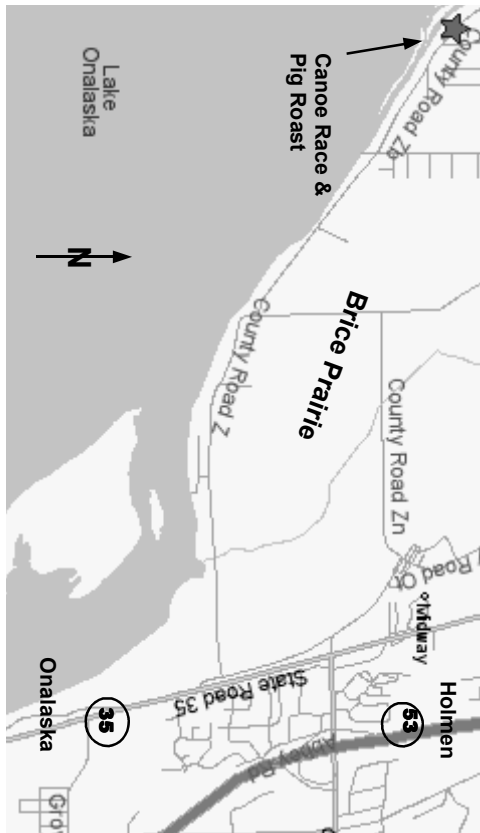
Each participant receives a pig roast ticket.
